

CANADIAN PRIVACY RIGHTS

This document applies to our Canadian operations. The *Personal Information Protection and Electronic Documents Act* (“PIPEDA”) and other provincial privacy laws provide you with the rights described in this document with regards to the personal information you provide to us or that we otherwise collect.

Consent

We collect, use and disclose your personal information with your consent or as permitted or required by applicable privacy laws. How we obtain your consent (i.e. the form we use) will depend on the circumstances, as well as the sensitivity of the information collected. Subject to applicable laws, your consent may be express or implied, depending on the circumstances and the sensitivity of the personal information in question.

If you provide personal information about another individual to us, it is your responsibility to obtain the consent of that individual to enable us to collect, use and disclose his or her information as described in this Privacy Statement.

If you wish to withdraw your consent to our collection, use or disclosure of your personal information, please contact us using the contact information in the “Contact Us” section below. However, before we implement the withdrawal of consent, we may require proof of your identity. In some cases, withdrawal of your consent may mean that we will no longer be able to provide certain products or services.

Opting-out of Use and Disclose Your Information

If you no longer want to receive marketing-related emails from us you may opt-out of receiving marketing-related emails by clicking the “unsubscribe” link at the bottom of any email you receive from us.

You may also opt-out of the following by contacting us directly using the contact information in the “Contact Us” section below.

- The use of your personal information for marketing and promotional purposes.

We will endeavour to respond to your opt-out request promptly, but we ask that you please allow us a reasonable time to process your request. Please note that if you opt-out from receiving marketing-related emails, we may still need to send you communications about your use of our products or services, or other matters.

Accessing and Updating Your Personal Information

We will not routinely update your personal information, unless such a process is necessary.

You may make a written request to review any personal information about you that we have collected, used or disclosed, and we will provide you with any such personal information to the extent required by applicable laws. You may also challenge the accuracy or completeness of your personal information in our records. If you successfully demonstrate that your personal information in our records is inaccurate or incomplete, we will amend the personal information as required.

We may require that you provide sufficient identification to fulfill your request to access or correct your personal information. Any such identifying information will be used only for this purpose.
